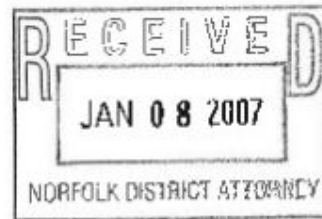

I don't expect everyday you get a letter from the general public applauding the work of the men and women in Norfolk County. This will be one of those occasions.

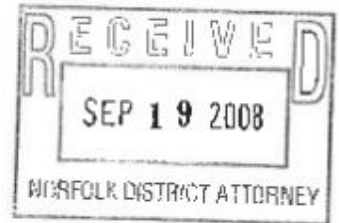
